Why I Use Photoshop Elements The reasons why I choose to use Photoshop Elements over other popular graphic editor such as Photoshop, GIMP, or Krita are multiple. Here are the three that matter most to me.

Accessibility The big advantage of Photoshop Elements is accessibility. If you are not an expert graphic designer or photographer, Photoshop Elements offers a simpler learning curve in comparison with Photoshop. It is easier to get started editing your images. Furthermore, it has a well-designed user interface. In other words, you can learn by doing more than just staring at the interface. It is almost impossible to make a mistake with Photoshop Elements and even more complicated to learn with Photoshop. You'll be able to get a great result right away. **Price** Photoshop Elements 2019 costs about \$60. Most graphic designers and photographers are not going to spend hundreds of dollars for a graphic editor. And when you compare it to paid alternatives like Photoshop and GIMP, it is incredibly affordable. The only complaint I have with the price is that you do not get the same access to the most advanced features of professional versions. An expected proposal by the EFTYAM Board of Trustees to sell portions of the campus to Evergreen (and perhaps other schools) goes before the trustees tonight. A portion of the meeting will be public; another will be private. These numbers are consistently different than the larger picture, however. The taxpayers do not want their money to be used for anything other than to educate and house our students. We need to go to the public to find out if EFTYAM can come up with a solution in line with the taxpayer's desire for the funds. If the deal is completed, we will be on the hook for unfunded potential student loans. The student loan bills for EFTYAM have been steadily increasing. During this time, funding has been turned down for some types of programs that are needed but not at the expense of the medical equipment we need to educate our doctors, teachers and nurses. Since the tobacco settlement money has been used to cover the increase in student loans, the university has only been allowed to provide about 7% of the funding as salaries. If we do nothing, the EFTYAM Board will attempt to raise more money through a new Master Plan Development process. I am opposed to the Master Plan since it takes a huge amount of time and resources to write. The Board should be throwing out a proposal for a new model that doesn't require the time and resources of a Master Plan. We all know where the funding is coming from, but if we don't ask ourselves the question – where do we want to go? – we will never get the answer.
