A: I can confirm that installing version 2014b of Matlab on the Mac I have does indeed give the "home-brew" installation instructions that you state. I have not tested the new Mac OS X builds, but if it does not work on those then it is possible that the installation instructions were only added to the Matlab releases for later versions of OS X. Alternatively, there may be security concerns with the installation on the latest OS X versions that you should be aware of. As for the version of the access plugins that you require, you can find it here: This version corresponds to Matlab R2014b. As for the version of the sensor connectivity plugin that you require, if you use the official versions from Mathworks then it should work in all versions of Matlab from 2012 to 2014b.
