The present invention is related to the field of covering products and more particularly to a stretchable covering which is designed for shading a roof or other surfaces. It is known to provide a covering of wide netting, such as heavy mesh netting, with a series of connecting straps, whereby the covering is stretched across a roof. In order to provide tension on the covering while it is being stretched across a roof or other surface, the covering may be anchored to a roof or other supporting surface. Typical systems include the use of hanger elements that are secured to the building and stretchable fasteners, which are secured to the covering and the roof or other supporting surface. This arrangement has several disadvantages. First, the fasteners make the covering cumbersome and difficult to maneuver on the roof or supporting surface. Appellant seeks review of his conviction for first degree murder, kidnapping, and other offenses on the grounds that the trial court erroneously admitted other crimes evidence and that the evidence was insufficient to

sustain the conviction for first degree murder. We affirm. FACTS During July and August 1981, appellant engaged in various assaults against a man and woman, Patricia Duluth, who testified that appellant beat and shot her several times while she was restrained. In October 1982, a jury found appellant guilty of criminal assault in the second degree, criminal assault in the third degree, and of criminal damage to property. The trial court admitted evidence of the Duluth assaults at appellant's trial for first degree murder, kidnapping, and other crimes. At the trial of the current charges, Duluth testified that on October 18, 1982, at 1:00 a.m., she was in the foyer of her apartment building. Appellant came up to her, and she recognized his car, so she left the foyer. A few minutes later, she felt a blow to her face. Duluth ran back into the foyer, and she was led by the assailant to a room, where she was handcuffed and told to get in a chair. Duluth testified that appellant
