Updating your way Photoshop enables two different kinds of "update." The first is called the Gradient Fill. Adjust Menu The Adjust menu is a powerful tool for editing images and for incorporating or modifying existing elements in other layers. The Adjust menu is a great way to work with a variety of tools such as brightness, contrast, saturation, exposure, exposure compensation, grayscale, and levels. This menu is available in the Layers, Drawing, and Edit tabs. Some of these elements can be set to affect multiple layers at the same time. Remember to set the option for Apply to: All to apply the changes to all the layers where the effect is. To delete a selected layer with this effect, choose Layer > Layer Via Copy or press Ctrl + J 2. State of Michigan Qui Tam Attorneys Whatever your age, if you have a business based in Michigan, you may have suffered injuries from a fraudulent activity or business situation. No one should be above the law. However, if you have chosen not to sue and the other party has illegally obtained your funds or merchandise, you can file a claim under the state's False Claims Act. If the person who was responsible for the fraudulent activity has been reimbursed, you can file a claim under the state's Qui Tam law. Michigan Qui Tam Attorneys: Understanding the Law Qui tam lawsuits allow you to collect a cut of the money recovered if you turn in someone who has defrauded the federal government. For example, if an accounting firm has committed a fraud against the federal government, you can file a claim under the state's False Claims Act. This means that instead of receiving a percentage of the settlement money, you get a percentage of the settlement money. The more you are willing to work for, the larger the percentage. Even if the activity is not against the federal government, the law allows you to file a false claim action against someone if you think they have committed a fraudulent action that could harm the federal government. For example, if you believe a company has been defrauding the federal government by overcharging for products they say they are providing or that they are selling products in violation of a contract they say they are not fulfilling, you can file a claim under the state's False Claims Act. People who are filing claims under the False Claims Act have to carefully follow the law. If you tell the wrong person about the fraud you think a business is committing, you can be punished. Even if you only tell the right person, the fraudster could decide to retaliate against you or your family. If the fraudster decides to retaliate against you or your family, you are not protected under the law. However, if you tell the state about the fraud, you can protect yourself.
